SPECIAL ORDER No. 58

EXTRACT

7. The following named O and EM, 1st Radar & VHF I & M Unit (Avn) will process by military airplane and/or rail or bus on or about 7 Mar 1944 from Robins Field, GA to Pratt Army Air Field, Pratt, KS on temporary duty for ninety (90) days, purpose, installation of classified material, RUAT to Capt HILT, and upon completion of this temp duty, unless sooner relieved, return to proper station. TOT. \$7.00 per diem is authorized for named EM if travel performed by air, for travel time only. If performed by rail, TO is authorized to determine number of meal tickets to be furnished EM while enroute under Auth: AR 30-2215. 1-5250 P 432-02 A 0425-24. TDN. Auth: Teletype ASCP M1E- 3-3525, HQS, ASC, Patterson Field, OH and ASC Reg 75-1, 9 Dec 1943.
